#### **Essential Functions:**

- Participate in program development and implementation in collaboration with DPH/BSAS and Advocates for Human Potential, including monthly conference call with BSAS/AHP.
- Supervise four staff, including (2) full-time ATR Coordinators, (1) part-time Billing Assistant, and (1) part-time ATR Shopper.
- Facilitate communication between ATR portals/providers and ATR Coordinators as needed.
- Contribute to achievement of project goals in a timely manner.
- Utilize the online ATR platform, Falling Colors, as a tool for supervision, data analysis, and documentation.
- Review and sign checks for participants weekly.

#### Other:

- Communicate with IHR's main office in Cambridge through use of shared online calendars, time sheets, and check in/out with supervisor.
- Attend monthly internal ATR supervisor meetings with Assistant Director and monthly agency staff meetings.
- Regular attendance and punctuality are required.
