III. PRESIDENT'S REPORT: Nicholas Smith

After I met with President Thompson, she expressed her desire for leadership across our campus community to be more consistent in acknowledging the land we are on. As president, I may not identify as part of these backgrounds; however, I want to recognize the land from which our university was built to create and foster an inclusive community.

"Westfield State University was built and currently sits on the unceded traditional ancestral territory of the Nip-muc, Poh-cum-tuck, Agawam, and the Wor-o-noco peoples. In recognizing the history and respecting the

sovereignty of Massachusetts Indian Nations, Westfield State University honors the heritage of Indigenous communities and their significant role in shaping the course of this region. Further, we recognize the wrongs done to those forcibly removed from their Homelands and commit to fostering an environment of inclusion that is responsive to the needs of First Peoples through our words, policies, and actions. The preservation and perpetuation of the customs and traditions of Indigenous nations are essential to our shared cultural heritage. A deep understanding of Native peoples' past and present informs the university's teaching, research, and community engagement in its ongoing effort to elevate the dignity of all people and serve as shared stewards of the land.

## IV. BOARD OF TRUSTEES' REPORT: Daniel Currier

Jack & I met with Director of Athletics Dick Lenfest and Carden Brown, Recreation & Intramurals Coordinator, on Friday to primarily discuss the Parenzo Gym renovations and student engagement in intramural activities.

As you all know by now, the Parenzo Gym, which was supposed to be open at the start of this semester, has once again been delayed due to the improper installation of padding on the walls. Barring any further issues, Parenzo Gym should be open within the next 3-4 weeks.

We further discussed student engagement in intramurals, which has been a topic of discussion for the past few months. I am pleased to report that all registration forms for intramurals are now located on the Nestwork, which will allow for a more user-friendly experience and make the process more efficient for Athletics. We have also asked Athletics to work with SAIL to advertise by email and social media that sign-ups are available through the Nestwork moving forward.

Tomorrow, I will be attending the Westfield State Employee Recognition Breakfast as a member of the Board of Trustees, where we will be honoring the contributions of our employees, celebrating milestone work anniversaries, and congratulating our new faculty and staff emerita recipients, including Barbara Hand, who served as an advisor to SGA for over thirty years.

Hello everyone. The Common Hour Policy Task Force, including Dan, Jack, and I, attended the All Chairs Meeting yesterday to present our proposal. We passed out the proposal, letter to governance, proposed block schedule overview, and Dan's card for contact to provide questions or ideas throughout the week. We discussed our reasonings and explanations, and then we asked for initial thoughts and opinions. As expected the idea of a new common hour, during prime time, had mixed reactions from faculty. Questions were raised about why we chose this time and if students would be willing to have earlier and later classes as a result. We explained that at other universities, taking an 8:15s is a norm and expectation. We had other professors say that this time would really affect their personal schedules, as well as the schedules of the department. We had other propositions for time blocks such as another 1:40-2:55 on Wednesdays or having both Tuesdays and Thursdays from 11:15-12:30, but getting rid of the current Friday hour. On a positive note, some department chairs were enthusiastic about the proposal and hope we continue moving forward. A.Advisory Committee on Academic Planning: Sarah Harrington

Hi everyone. This past Thursday, January 25<sup>th</sup> ACAP met to further Discuss the Academic Masterplan. There were two focuses of this meeting. The first was to change the verbiage of theme 3: Invigorating, redesigning, and creating academic program's description. This change is to support and continually assess the Gen Ed Curriculum and support SCORE. Later in the meeting, we broke into groups and workshopped the performance indicators for each sub-section in all three themes. Once the verbiage is finalized and qualitative data is collected from campus groups the Academic Master Plan will be presented to the Board of Trustees. Moving forward, we will go back to bi-weekly meetings. Thank you!

VII. VICE PRESIDENT'S REPORT-STUDENT EQUITY: Joseph Bonilla

On Friday, I met with community partners regarding collaborate efforts for this year's Amore Galore. I have confirmed that both Westfield State Health Services and Tapestry – Westfield will be tabling during Amore Galore events on Saturday, February 10th. This is a great opportunity for students to learn about the sexual health resources available to them both at the institution and in the Westfield community.

With the changes in the Division of Justice, Equity, Diversity, and Inclusion, the division has restructured their events for the Month of February. I want to make you all aware and encourage you to join the division tomorrow in welcoming 2024 Grammy-nominated Poet, Kevin Powell, to our community. He will be giving his speech "We Gon' Be Alright: Young America and the Future of Our World".

As I will not be seeing you all on Thursday, I want to acknowledge Black History Month and its significance to our- and other- communities across the United States. The month celebrates the contributions of Black Americans to the United States, despite our history of racism and oppression. It honors all Black people from all periods of U.S. history,

from the enslaved people first brought over from Africa in the early 17th century to those during the civil rights movement to those living in the United States today. This month is a time to reimagine and work toward a better future for the next generation of Black Americans that encompasses the values of dignity and respect for each individual.

Today the Campus Pride Committee's subcommittee on Gender Inclusive Restrooms met with Joshua Hetrick the Associate Director of Space Management in Facilities to discuss the logistics of creating more spaces on our campus and the inquire on updates to current projects. It seems that for spaces like Bates and Dower, we are unable to repurpose existing facilities into Gender-inclusive restrooms due to outdated plumbing codes meaning that renovations must be made to include these new projects. And, considering the scale for a renovation for either of these buildings, the costs exceed our financial bandwidth to work on them. The subcommittee will be convening with the committee at-large to discuss this information and formulate next steps so stay tuned for those details.
